- 4. The order can be placed by:
 - a. IMA State Branches through their State Secretaries/State Schemes.
 - b. IMA Local Branches through their Branch Secretaries
 - c. The order has to be placed to the email of respective 3M State Coordinator (list attached) by the State Branch or Local Branch with a copy of order to imamaskinitiative@gmail.com.
 - d. Orders from IMA branch secretaries, IMA state branches or their schemes will only be entertained. The genuineness of the order will be checked.
