3. Table 'C' is Showing the amount to be send to IMA Hq If State deposit GST. In that case state has to send the challan copy of GST paid on membership fees (Rs. 1310/- in single membership and 1963/- in couple membership). In the absence of GST challan copy the membership will not be processed.
